Dear Exhibitor

A warm welcome to Lourensrivier – Feesmark / Craft Market!

Our **selection criteria and conditions** are as follows:

- ☺ **ENTREPRENEURS with handmade articles will get more attention.**
- ☺ **Good quality is of utmost importance.**
- ☺ **Reasonable prices. The market is aimed at Christmas shopping and expensive articles do not sell.**

The Feesmark / Craft Market is aimed at Christmas shopping and we strive to have a big variety of articles to sell. The Lourensrivier Gemeente act as agent only and are exempt from tax. The list of products should be handed in at the screening and must be completed accurately. Please make sure that you use the selling price that will be applicable at the Feesmark / Craft Market.

SCREENING: Saturday, 26 May 2018

Be there 15 min prior to the scheduled time to make provision to unpack your items. After screening you should clear the table as soon as possible. Refer to no 3 below for screening times. Please note that screening for the different departments will start on the hour sharp. (There will be representatives of various craft markets at the screening.)

PLEASE DIARISE THIS DATE AS YOU WILL NOT BE REMINDED OF IT AGAIN.

IMPORTANT INFORMATION:

1. When and Where

26 October – 10 November 2018

The church hall of Lourensrivier Gemeente is situated on the corner of Broadway en Da Gama Road, Strand, on the main route to Gordons Bay. There is a big hall, with coffee shop and ample parking for your convenience.

2. Business Hours

The Feesmark / Craft Market will be open on **weekdays from 09:00 to 19:00** and **Saturdays from 09:00 to 17:00**.

3. Screening

All application forms must be signed by the exhibitor. We would appreciate all applications to be handed in by no later than **Wednesday, 23 May 2018**, but we will accept late entries on the day of the screening. (Early applications will ease up our administration.) You could either:

You will be notified by latest **30 June 2018** whether your goods have been approved for the Lourensrivier Feesmark / Craft market.

All perishables / edibles must contain the following:

Expiry date; storage information ie. shelf or fridge (after opening).

On the day of the screening you should display examples of your goods to the selectors. **All your items should be priced as at the Feesmark / Craft market and the same prices should reflect on the item list.** You must leave samples of all perishables/edibles clearly marked for Lourensrivier Feesmark / Craft market and with your name as there will be selectors from various markets. *It is your prerogative to choose in which categories your products fall, should there be more than one, use the time slot where you have the most products.*

NB Please leave your product list with prices and number of stickers per item needed on the table for the selectors.

08:00 – 09:00 Jewellery, Beads

09:00 – 10:00 Needlework, Fabric paint, Knitting and Crochet

10:00 – 11:00 Candles, Pottery, Glass, Porcelain and plants

11:00 – 12:00 Gifts, Bath products, Toys, Dried flowers

12:00 – 13:00 Bites to eat / Perishables

14:00 – 15:00 Wood, Metal, Leather and Cane

15:00 – 16:00 Paintings, Cards and Miscellaneous

Should you not be able to attend the screening in person you have to send a representative. Should you fail to present your products at the screening, you will be disqualified. Even if you have been and exhibitor at previous Feesmark / Craft markets, you have to submit your products again – you cannot take for granted the fact that you've been an exhibitor in the past.

4. Registration Fees and Commission

Registration for the duration of the Feesmark / Craft market (14 days) is **R460 per table** (i.e. two tables @ R920 and ½ table @ R230). This fee is payable on or before **31 August 2018**. Deposits are non-refundable. **Our banking details: NGK Lourensrivier-Strand, ABSA current account, Acc no: 420580231, Branch code: 334312 (Strand). Please use "Fees" and your name and surname as reference!!!** **17% Commission** on all sales will be payable to the church. Therefore your prices should include the 17% commission. Also make provision for theft and breakage/damage. Prices are not to be changed during the Feesmark / Craft market or on the day of screening. Please round your selling price to the nearest Rand.

5. Tables

The tables are approximately the size of a bedroom door (±180cm x 90cm), but sizes may vary. We will try to meet your requirements as far as possible. We will provide hessian to cover the tables, but you are welcome to use your own tablecloth.

6. Set-up and Clear

The hall will be open on **Thursday 25 October 2018 from 13:00 – 19:00**. You are responsible for your own table and should unpack and display your products. Should you not be available to unpack your products, alternative arrangements must be made. **Additional stock must be kept under the tables**. Our responsibility in terms of security starts at 19:00.

The Feesmark / Craft market ends on **Saturday, 10 November 2018 at 17:00**. **The exhibitor or a representative must be at the church at 17:00 sharp for the official closure and only afterwards (± 17:30) may the clearing of tables start.** The Feesmark / Craft market's doors only close at 17:00 and we need to give the customers time to finish their shopping. **Under no circumstances are you allowed to start clearing your tables before the official closure.** **The hall must be vacated that same afternoon, you have till 19:00 to clear your goods.** Past incidents have forced us to deduct a 30% fine of the exhibitor's turnover, for early clearing. The same rule applies should you run out of stock and/or not have sufficient stock for the whole event.

We thank you in advance for your co-operation in this regard. The safety and security of the exhibitors and their products are from the utmost importance to us and therefore we cannot make any exceptions. The organising committee will do their utmost to take preventative measure for damages or loss of goods. **Lourensrivier Church and the organising committee take no responsibility for any loss or damages to goods.**

7. Tasters on tables

All tasters (sauces) must be in a squeeze bottle with spout and clearly labeled. If it is a type of jam or thick sause, simply enlarge the spout by cutting a peace off. If you have a product that contains chunks, you may use a bowl. This is to prevent the sauces from drying out while on the table, it will be more hygienic than an open bowl and there will be less waste at the end of the day.

8. Supervision / Security

There is no need for you to be at the Feesmark / Craft market for the whole duration of the event. All we require is for you to do **2 shifts of 2 hours each**. (Should you not be able to be there yourself, please appoint someone in your stead.) Exhibitors with expensive jewellery are responsible for their own supervision at their stall. Please call Elfie on 073375 6727 or 021 850 8080 [or Lizette on 083 500 5400] to let her know which shift you will be able to work. Although most of our supervision is voluntarily, we use responsible people that will take good care of your exhibition. Exhibitors that will not be able to work a shift can pay an additional fee of **R100 / shift** (with registration) in order for us to arrange for someone in your stead. Should you not pitch for your shift we will be forced to deduct **R150 / shift** from your turnover at the end of the market.

9. Central Pay point

We have a central pay point with credit card facilities.

10. Payment

Your payment will be made by no later than **14 December 2018** directly into your bank account. PLEASE make sure that we have your correct details! No cash pay-outs will be made.

11. Price stickers

We will print price stickers for you. It is very important that the description (**no more than 23 characters**) and price of your goods are marked clearly on your form. We will use this form to print your stickers. Every item should be clearly marked on a level surface for the scanners to work properly. Should the item be too small, please attach a piece of carton with string or put it in a small plastic bag to put the sticker on. **Items without price stickers will not be accepted.**

12. Marketing

Before and during the event we do a wide range of advertising and marketing. We use posters, banners, pamphlets and the local radio stations and newspapers. Please keep this in mind when you do your stock planning for the market!

Our Feesmark / craft market can only be a success with your support. We look forward to meeting you for the first time or to seeing you again. We ask for your prayers that we will have a safe and successful event.
